1. Outline progress over the last 6 months (April – Sept) against the agreed project implementation timetable (if your project has started less than 6 months ago, please report on the period since start up to end September).

An inception meeting was held on 7 July 2022 to bring together core staff working on the project, outlining key milestones and project activities.

Under Objective 1, we organised an online training workshop on 12-13 September 2022 for 6 FFI staff members (3 men: 3 women) and 4 BIOMETEPE staff members (3 men: 1 woman) in Nicaragua. The workshop focused on the crime scripting process and was delivered in a train-the-trainer format in order for participants to facilitate a crime script workshop in person in Ometepe. After the workshop, participants completed exercises as a team to entrench learning and the in-person workshop is planned for November 2022. A repeat of the same online and in-person workshops is planned for Liberia in November 2022.

Objective 2 has focused on outreach with criminology and crime science academics and practitioners to begin discussing existing MEL frameworks and approaches, and how these could be applied to IWT. Through a Miro board, we have shared ideas of resources and analysed the benefits and limitations of different approaches, as well as general best practices guidelines.

Under Objective 3, we've developed a communications plan that outlines potential avenues to meet our two main communications objectives: 1) To raise awareness and endorsement of the crime prevention toolkit; 2) To socialise alternative approaches to addressing IWT. Of these, we've sketched out a webinar series, with the first one being held online on 10 November 2022 to discuss the topic of conservation-criminology partnerships with two guest speakers.

2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

Three staff members in the UK and Liberia have changed (two have left FFI and one has been an internal workload change for a financial contact point), and one new staff member has been recruited for delivery in Nicaragua as per our grant proposal. Where staff members have left, we have assigned other staff to work on the project in order to limit delays with project delivery. A staff change request was submitted on 30 September 2022 and accepted on 24 October 2022. 3. As suggested by the reviewers at Stage 2, we have met with the two other grantees delivering projects also focused on chimpanzee trade in Liberia. We met with the Wild Chimpanzee Foundation on 7 June 2022 and PCI Media Impact on 13 June 2022, where we discussed our respective projects. These conversations were fruitful to ensure there was no duplication of activities and to identify areas for joined up working. Since, we have been invited to join PCI Media Impact's coalition of organisations to contribute to the design and strategy of their approaches and materials. Similarly, we will be inviting both project grantees to participate in our crime scripting workshop in November 2022.
