The current major threat to all eight pangolin species is illegal poaching to feed demand for pangolins scales primarily used in Traditional Chinese Medicine (TCM). This project will develop a rigorous evidence base on consumer behaviour in southern China, a major end market for pangolin scales. The evidence collected through this project will inform the design of a series of experimental behaviour change interventions employing the latest behavioural science methods.

Asian pangolins have been heavily trafficked, reaching near extirpation in the wild. As a result, African pangolin species are increasingly targeted to meet Asian demand for their scales and other products. These illegal wildlife trade (IWT) networks are undermining the security and livelihoods of communities where the remaining populations of target species exist through links to other forms of criminal activity and enticing community members to engage in wildlife crime (Helen, 2020).

The African Development Bank (2016) estimated that in 2014 the economic loss from IWT was 15 billion USD in Africa, which is about 30% of foreign aid. Villagers who fight against poaching groups may be harmed by poaching groups, while villagers involved in poaching are vulnerable to being arrested or harmed in law enforcement actions and unable to provide economic resources for their families or losing their lives. Wildlife is an important natural asset for rural communities and an opportunity for them to develop sustainable livelihoods. The IWT exacerbates the fragile economies of rural communities and undermines their opportunities to develop sustainable livelihoods.



Reducing the demand for pangolin scales in China and the related supply chain's negative pressure on security and livelihoods abroad, requires a modification in the TCM consumption environment. In clinical institutes, medical practitioners and staff provide access and guidance on the medical use of pangolin scales to consumers, potentially creating an environment encouraging demand. Although there have been several studies (e.g., USAID, 2018; Zhang et al., 2020) on the willingness and motivations of end consumers of pangolins, to date there has been little research to identify key actors, such as clinical institutes, along supply chains who can impact demand. Thus, there is a lack of knowledge on the motivations of, and impact of drivers of consumption from the supply side.

This project will use evidence-based behavioural insight approaches to gather evidence and design interventions to reduce demand for pangolin scales in TCM. We will identify key actors and stakeholders along the supply chain that are critical to reducing the consumption of pangolin for medical use and investigate how to facilitate the desired behaviour changes of these stakeholders.

Demand reduction campaigns targeting consumers of pangolin scales have been implemented in Vietnam, China, Thailand, and some African countries. WCS's study of the pangolin scale trade in China identified that there are key actors along the supply chain, such as hospital and clinic staff, government administration officers and TCM practitioners, in addition to the consumers. These actors have a considerable influence on consumer decisions to purchase medicines containing pangolin scales and their role has been insufficiently investigated and targeted in previous interventions.

There is little research focused on understanding which behaviours of actors along the supply chain influence consumers of pangolin scales, and much less on the design and implementation of interventions to change such behaviours.

To fill this gap, this project will use behavioural insight approaches (Richard, 2009) to identify specific behaviours of these "key actors" that can be changed to influence TCM consumption of pangolin scales, along with the barriers to such desired changes. Evidence-based interventions will be developed to inform future efforts to change targeted behaviours and reduce consumption of pangolins in TCM. We will also present the proposed interventions to relevant organizations to generate their commitment to future implementation.

The project will employ behavioural insight approaches to identify key actors along the supply chain and understand how they influence pangolin scale consumption, generating greater understanding and evidence to support design of supply-side strategies to reduce demand. Knowledge and evidence generated in the project will contribute to the commitments in Action A.I of London Conference Declarations, Action 2 in Actions Section A of the Kasane Statements, and Action A of the Hanoi Statements.

Potential key actors that may be studied in the project include clinical practitioners and other staff employed by medical care providers, both public and private, as well as administration agencies that regulate the legal clinical use of pangolin scales. This project will help create an understanding of how these key actors influence consumer behaviour and will inform health sectors and governments agencies such as Health Committees at all levels about how to effectively take responsible, accountable, and traceable measures to stop illegal pangolin products from entering





WCS is committed to diversity, equity, and inclusion in all our programs. For this project, WCS and project partner staff, regardless of gender, will participate equally in project implementation and decision making.



We will review the design of surveys and interviews and collect data disaggregated by gender. This will allow us to identify any specific gender roles along the supply chain including gender specific barriers to the behaviour we intend to change and ensure research activities and interventions developed are gender sensitive. We will ensure data collection techniques accommodate and are sensitive to gender requirements, noting the potential need for additional conditions to accommodate TCM practitioners within hospital environments and lactating women, such as providing online options and flexible timelines.

The knowledge gained from this project will generate a better understanding of the behaviours of key actors along the supply chain that influence pangolin scale consumption in TCM and inform evidence-based interventions for behaviour change. The tools and knowledge developed in this project will support SCNU to use more diverse approaches for more efficient demand reduction efforts in the future.

In the short-term the project will provide valuable information to inform the application of behavioural science techniques to reduce the demand of pangolin scales in TCM. This will allow governmental and non-governmental organisations to implement evidence-based interventions in the long term to effectively reduce pangolin scale consumption, and in doing so reduce poaching and illegal trade pressures on wild pangolin populations. Pangolins are key species controlling termite and ant populations in the ecosystem, protecting wild pangolin populations will contribute to biological pest control and ecosystem health (Chao et al. 2020). This will benefit livelihood security in range countries through reducing the loss of harvests and construction damage caused by termites and ants, providing more legitimate employment opportunities, and reducing personal and property threats from crimes. Demand reduction for Pangolin scales can also drive reduced poaching and illegal trade of pangolins and in doing so allow for reduced costs of law enforcement in range states combating trafficking crimes. This will allow local governments to invest more resources in developing a healthy economic system and reducing poverty on the ground.

This project will also promote the effective use of behavioural insight techniques in conservation that are novel in many countries. These methods can be highly effective not

wild populations are threatened by illegal trade, but more broadly on IWT interventions.

As TCM remains a major use of pangolin scales in China, hospitals and clinics are important environments for its consumption. This project will (I) produce a behaviour map through key actor surveys around consumption scenarios in hospitals and clinics, (II) determine barriers to changing target behaviours, and (III) design and shortlist the most promising interventions to influence behaviours. A series of workshops will be organized to ensure multi-actor involvement and identification of appropriate interventions through sharing of the evidence gathered by the project and helping to enable this evidence to inform future efforts.

The outputs from this project will fill knowledge gaps and build a better understanding of pangolin scale consumption in TCM and provide evidence to inform future interventions to reduce demand. We will co-develop a workplan for future interventions with stakeholders and seek resources to pilot these interventions to reduce pangolin scale consumption in Chinese hospitals and clinics. This decrease in demand is key to reducing pressures on African pangolin populations and improving community security where these IWT networks operate.





WCS has built our project team with the knowledge and capacity to apply behaviour science approaches in understanding and reducing wildlife consumption of endangered species for medical use in China through a previous and on-going project funded by EU commission. SCNU, as our project partner, has a high reputation in behavior science research in China and will for the first time expand their research into the IWT issue. This partnership is expected to enable another local academic force to join the exploration of solutions for countering wildlife trafficking in the long term. Experience and lessons learned from this project will help us to design a behavioural intervention strategy that will lead directly to the development of a DEFRA IWT Main project, which will be incorporated into the current efforts of WCS and other organizations (e.g., TRAFFIC and Oxford University), ensuring project sustainability and implementation of the strategy to be developed.

Our internal controls and project management will monitor the responsible, efficient and transparent use of project funds. This project will also provide high value for money by leveraging the capacities and resources of related individuals, groups and government agencies partnered with WCS and securing resources from other donors.

WCS has a range of safeguarding policies that aim at ensuring compliance with international human rights and social safeguards standards. They will be applied consistently during the project.

WCS will apply an Internal Review of Research with Human Subjects. WCS has signed a Federal Wide Assurance (FWA) under which we agree to adhere to 45 CFR part 46. In accordance with this, WCS ensures that all WCS staff involved in collecting data from human subjects must first complete training in human subjects' research, and all human subjects research are approved by the WCS Institutional Review Board (IRB).

WCS will also adhere to Chinese laws and regulations on data treatment and personal information protection. We ensure all interviews and surveys are conducted anonymously and with free and prior informed consent. All data collected in this project will be stored and treated in a safe manner and in compliance with internal information security protocols.

WCS does not collect or process sensitive personal information: political opinions, trade union membership, religion or philosophical beliefs, health including mental or physical health, genetics or biometrics, sexuality, or private life.

WCS is one of the first officially registered international NGOs in China in 2017 as the new Chinese international NGO management law become effective. WCS China staff attend compliance trainings held by the National Forestry and Grassland Administration to ensure our work fully complies with relevant Chinese laws and regulations. Although this project will not include indigenous communities, for interviews and surveys targeting human beings, we will follow WCS's ethics requirements and protocols. All surveys and questionnaires will be reviewed and approved by WCS's IRB, and all staff involved in the survey are required to pass the Ethics Concepts for Human Subjects Research training led by qualified trainers holding a Collaborative Institutional Training Initiative (CITI) certification. Currently WCS China CWT team has two staff holding this certification who have provided such trainings to WCS staff and the partner.

WCS has summarized best practices from previous similar studies and will use these during this project implementation. Through an adaptive method, we will also summarize the best practice from this project to enrich our knowledge for future projects.




