1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

As of 30 September, all four booklets had been written (Activity 1.1). Two had been translated, illustrated and printed (rhino and pangolin) (Activities 1.2 and 1.3), and the two others were awaiting approval from the Viet Nam CITES Management Authority (VN CITES MA); we were behind schedule on completing Activities 1.2 and 1.3 but expect them to be completed by 31 December 2015 (3 months behind schedule).

The rhino booklet was made into a cartoon movie (Activity 1.5), and it made its debut broadcast on national television in Viet Nam on World Rhino Day, 22 September 2015 (Activity 1.7). As of the end of September we did not have a contract with a national television company to broadcast the cartoon movies one hundred times (Activity 1.4).

A screenplay was written for the pangolin movie and, at the end of September, this was awaiting approval from the VN CITES MA. We expect the pangolin movie to be ready for broadcast by 31 December 2015 (3 months behind schedule). The elephant booklet has been approved by the VN CITES MA and we are preparing the screenplay for it now. We will prepare screenplay tiger movie once the booklet are approved by the VN CITES MA. The elephant and tiger screenplays will also need VN CITES MA approval before they are provided to a production company. We expect the elephant and tiger movies to be ready for broadcast by 31 March 2016 (6 months behind schedule).
