1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

Output 1: Electronic booklets and videos are produced, disseminated, displayed, and, for the videos, broadcast on national TV.

As reported in our annual report, all four booklets were written (Activity 1.1), translated into Vietnamese (Activity 1.2), and illustrated (Activity 1.3); two of the books (rhino and pangolin) were converted into animated videos (Activity 1.5); one of the books and video (rhino) were posted to websites (Activity 1.6); and one of the videos was broadcast on national TV (rhino) (Activities 1.4 and 1.7).

During April through September 2016: the two remaining books (tiger and elephant) were converted into animated videos (Activity 1.5); one additional book (tiger) was posted to websites (Activity 1.6); and two of the videos were broadcast on national TV (rhino and pangolin) (Activities 1.4 and 1.7).

As noted in our April 2016 annual report, and our change request, the completion of these activities is behind schedule and we had a significant shortage of funds to air all four videos one hundred times each, as per the proposal. However, we were able to find additional funding (USD 220,000) to support the airing of all four videos on Viet Nam's national television station, VTV, one-hundred times each from 1 September through 31 December 2016. The rhino and pangolin videos have been airing since 1 September; and at present, all four cartoons are being aired on national Vietnamese television. VTV will provide viewership numbers once all airing has been completed.

Finally, all four books and videos will be available on websites before the end of December 2016.

Thus, by 31 December 2016, the activities associated with Output 1 will be completed; this is approximately six months behind schedule.

Output 2: People who live in households with children view the electronic booklets and video.

We are in discussions with the Viet Nam office of the international polling firm, Nielsen, about a

national public poll to be undertaken near the end of December 2016 to ascertain the percent of public who saw the cartoons and booklets and the impact of cartoon or booklet viewing on stated intent to buy or use the wildlife parts and products. The results of the survey will be available before the end of January 2017. The poll and the poll results are approximately 3 months behind schedule.

Output 3: People indicate in a public opinion survey that they viewed the electronic booklets and videos and that this changed their intent to buy or use parts of rhinos, elephants, tigers and pangolins.

As noted above, the Nielsen survey will measure the impact of cartoon or booklet viewing on stated intent to buy or use the wildlife parts and products. The results of the survey will be available before the end of January 2017. The poll and the poll results are approximately 3 months behind schedule.

The project will be completed by 31 January 2017; this is on schedule.

Due to problems experienced prior to the last six months, as detailed in our April 2016 annual report and change request, we started out this six month period approximately six months behind schedule. We also needed to find significant additional funding to air the cartoon videos one hundred times each on national television.

However, we were able to find the needed funding from an outside source. Furthermore, by compressing the amount of time the videos would be aired on national television into four months rather than one year, the project will be able to finish on schedule, by 31 January 2017.
