Translations for all versions have been completed during this period. This includes Portuguese, Spanish, French, Thai, Vietnamese, Mandarin, Cantonese and Swahili.

Online feedback forms (to assess the training tool's impact and use) have been completed in all nine languages. Feedback forms consist of 11 questions that cover: demographics of respondent, their job type/department in enforcement, an assessment on each of the 17 modules in the tool, where they used the training tool, and overall comments. This will be the main tool used in our monitoring and evaluation.

Final copies of the English-language version and Portuguese-language version are now complete and online at combattingivorytrade.com.

French and Spanish versions will be completed before the 69th CITES Standing Committee (November 2017) so that it is complete in the official CITES languages. Requests will be sent to the CITES Secretariat that there is an official mention of the training tool, to aid its distribution. These will be disseminated using the website and on USBs.

The remaining five language versions are on schedule to be completed by early 2018. EIA has established a partnership with UNDP in Thailand, to include the training tool in one of their training programmes; this opportunity will be used to solicit direct feedback from the participants and users of the training tool in the country.
