Output 1: Political commitment for cooperation between Viet Nam and Mozambique to combat IWT is strengthened through legal mechanisms and improved protocols.

Activity 1.1 Prepare draft MLAT and SOPs with Vietnamese agencies - Completed

Activity 1.2: Secure agreement on MLAT and protocols for enforcement cooperation

The signing of MLAT (Mozambique – Viet Nam Mutual Legal Assistance Treaty) on criminal matters in December 2018 marked the completion of this activity. The document was ratified by the President of Viet Nam in July 2019, and on May 21, 2020, Mozambique's Prime Minister, on behalf of the Council of Ministers, ratified it by a promulgation of the Resolution 35/2020. As such, the MLAT is now effective for implementation in both countries.

With leveraged funds from the Bureau of International Narcotics and Law Enforcement Affairs (INL), in late 2019, WCS initiated discussions to organize the first bilateral review meeting for Viet Nam's SPP and Mozambique's PGR to enhance bilateral cooperation in prosecuting transnational crimes including wildlife crimes. This meeting was delayed twice in November 2019 and February 2020 due to presidential and National Assembly elections in Mozambique and because of the impacts of COVID-19; it is currently rescheduled for mid-2021.

Activity 1.3. Organize a series of face to face and virtual briefing sessions on legal framework and MLAT procedure between Viet Nam and Mozambique - Ongoing

This new activity was approved in September 2020. We plan to conduct two face-to-face and/or virtual briefing sessions, depending on COVID-19 travel restrictions in Viet Nam, on legal frameworks and MLAT procedures between Viet Nam and Mozambique for Vietnamese prosecutors from key provinces implicated in the trafficking of rhino horns from Mozambique. These meeting will discuss actions on how to proceed mutual legal assistance, convening

witnesses and experts, collecting and providing intelligence, evidence, and information exchange for a criminal prosecution, and providing a point of contact for agencies as necessary. Meeting briefs will be shared to the focal contact agencies at Mozambique's Public Prosecutor's Office (PGR) and the Ministry of Justice (MOJ) for subsequent coordination. This activity is planned for Nov-Dec. 2020. Updates will be in the final annual report.

## Output 4: Vietnamese residents in Mozambique perceive a greater risk of partaking in wildlife crimes

Both governments have responded to the COVID-19 pandemic with a series of actions such as quarantining infected locations and people, closing border gates, and social distancing in vulnerable localities. Gatherings, crowd meetings and cross-province/international travels are also discouraged or cancelled. Under Activity 1.2, we planned to work with the Viet Nam's SPP to co-host a bilateral review meeting with Mozambique's PGR. The meeting was delayed twice and rescheduled to mid-2021 with a hope that COVID-19 will be better controlled globally.	
Similarly, we have seen very little action by the Governments of Mozambique and Viet Nam following sharing IWT intelligence products and partly due to government limitations on travels and gatherings, we changed our methods of collecting IWT information to desk-based reviews and rapid provincial verification trips when the travel restrictions were lifted in Viet Nam. In September 2020, we received approval for a change request asking for a no-cost extension of additional six months to December 2020 to ensure we have enough time to gather additional field information on IWT in key localities and to continue to follow up with government partners.
