1. Outline progress over the last 6 months (April – Sept) against the agreed project implementation timetable (if your project has started less than 6 months ago, please report on the period since start up to end September).

Activity 1.3: Conduct review of Nepal's recent legislation (i.e. CITES law), and conduct consultation with legal/forestry officials to summarise and clarify Nepal's rules about orchid harvest and trade

Review of Nepal's recent legislation completed. We submitted the manuscript for publication in *Biological Conservation* and is under review. This analysis was also used to develop a Policy Brief, which has been published.

Activity 1.8: Analyse primary data (field observations, interviews, etc.) into a report

We have prepared site-specific reports based on field observations and interviews with stakeholders (enforcement, community forest user groups, harvesters, traders, middle-men). We conducted a series of trade-chain mapping activities with a range of stakeholders at various levels (community, district, province, and national level). We are working on a manuscript to incorporate a trade-chain mapping exercise. Most notably, this has been developed into a draft Policy Brief, which will be completed once all of the 2022 data is collected (this was delayed due to COVID).

Activity 1.9: Prepare journal publication

We submitted a manuscript on the legal review (see, Activity 1.3)

Activity 2.3 Local NTFP harvester self-reporting trialled in 1 CHAL harvester community for 4 months with engagement of the eco-monitor

We started an additional round of harvest monitoring with the same harvesters in the new harvest season from September 2022 (expected to last until November). This was needed because our original monitoring was delayed by COVID, and the project no-cost extension allowed us to start a second round. We are working on the data entry and draft report of harvester-collected data. Alongside this, we are working on a journal manuscript and policy brief.

Activity 2.5 Analysis and report on orchid harvest dynamics, based on community-based reporting data to help inform sustainability of legal harvest (see Output 2; baseline=0 such analyses globally, end Y2)

We have done this for the data collected during the first round of harvest monitoring and are starting it with the additional data (see Activity 2.3).

Activity 2.7 Trial establishment of a district-level Task Force to discuss new orchid data (i.e. Indicators 2.1-2.6) implications for their 5-year District Management Plan (baseline=no such platform exists, and orchid resources management is not currently explicit in the current management plans; established mid-Y2, with ongoing support into Y3)

We revised this in our logframe (approved by IWTCF) to instead focus on re-activating and engaging the Wildlife Crime Control Bureau (WCCB). We have been meeting with WCCB members to include orchids in their conservation and enforcement plans. We also conducted an interaction program with the WCCB members of Hetauda, a sub-metropolitan city in the Makwanpur District of Bagmati Province in central Nepal, to present our results and discuss how these affect their planning.

Activity 2.8: Establish Task Forces in the target village, including appointment of an independent eco-monitor to oversee the harvester data collection

As above, we revised this to focus on engagement with WCCB and removing the Task forces. We are continuing to follow up with the district-level WCCB's medicinal plant focal team and their progress (also see Activity 2.7). The eco-monitor remains active in the monitoring of the data collection by households (see Activity 2.3).

Activity 2.9: Harvesters self-collect data through their normal peak-season for harvest, with regular (e.g., weekly) check-ins and engagement with the independent eco-monitor to submit their data.

We resumed an additional round of monitoring with the same harvesters in the new harvest season for at least 2 months (See Activity 2.3).

#### Activity 3.1: Prepare and publish policy brief, "Combating illegal orchid trade in Nepal"

Activity 3.2: Prepare and publish policy brief, "Trialling monitoring and exploring sustainable legal orchid harvest to reduce IWT"

We have prepared a draft based on the harvest monitoring, and are waiting to update this with data from the second field season (ending Nov. 2022).

Activity 3.5: Recruit "champions" in CHAL and nationally during various meetings/workshops, keeping records of likely supportive candidates and keeping in touch with them via meetings and email updates

We have identified 30 champions in CHAL and nationally who have engaged with us supportively throughout the project, including government officials. We have prepared a brief introduction of each Champions including their contributions/commitments on orchid conservation. We are working on handover documents (certificate and a token of appreciation) to formally handover to them before December. We will continue to share the final results of our analyses with them, encouraging them to engage with these, share them, and see how they influence their work.

## Activity 3.6: Monitor government enforcement data/seizure records throughout project the project duration

Activity 4.1: Workshop conducted in 5 harvester communities/Community Forest User Groups in CHAL (n=200 participants) to highlight baseline data collected, provide legal clarity, and discuss their implications for harvester livelihoods and sustainability

We conducted 4 half-day workshops with 130 participants (2 in Kaski and 2 in Makwanpur Districts) to highlight the results from baseline data collected, legal clarity about status of orchid trade in Nepal, and implications for harvester livelihoods and sustainability. One more workshop is planned for Gorkha District.

### Activity 5.1: Maintain active Facebook and Twitter presence, highlighting project progress including sharing knowledge products.

Active social media outreach ongoing. So far we have posted 78 posts with the #NepalOrchids hashtag over Greenhood Nepal's social media platforms

### Activity 5.2: Publish 4 blogs (e.g., on PVA, harvest, enforcement data analysis, trade data analysis)

We submitted an article to the American Orchid Society, which is in press. Also, we submitted an article for the IWT Challenge Fund newsletter. We have two further drafts prepared.

Activity 5.3: Publish 4 editorials in Nepal (e.g., on PVA, harvest, enforcement data analysis, trade data analysis)

We are working on an editorial for HimalKhabar, a famous media platform in Nepal. We are also discussing a long-read story with ThirdPole that will cover our work. We have shared about our project progress in different interviews and platforms like Harper's magazine and handbook publication of Division Forest Office Makwanpur.

Activity 5.4: Participate in international conferences to highlight outcomes (target conferences: SCB, ICCB, National sharing platforms)

We presented the project at 1 national conference (Nepal Academy of Science and Technology Conference), and 1 international conference (Women in Nature Network Conference)

#### Activity 5.7: Side-event at CITES Meeting

We have had considerable catch-up during this period due to COVID. This included extending our harvester monitoring for a second season, which itself was somewhat delayed due to an extended monsoon season. It also involved postponed travel by J.Phelps to Nepal (Sept. 2022) and postponed travel by R.Bashyal and K.Paudel to the UK (Oct/Nov 2022) due to post-COVID visa delays. This was all possible due to a no-cost extension, which was approved via NIRAS-LTS; with this extension the changes should not affect the budget or timetable.
