The project was signed on 28th September 2021 between NTNC and IWT Challenge Fund with the starting date November 01, 2021. Although no activities are planned for the reporting period (April to October 2021) under this project, we have initiated the preparatory work for the project implementations and outlined the progress as follow.

- Community consultation with Kalika Community Forest has been carried out for the project implementation. A request letter from the community forest has been received on 26 October 2021 showing the willingness to implement and community ownership and partnership for the implementation of the project.
- 2. The farmer household selection process is ongoing for:
 - a)- Cow farming
 - b)- Goat farming
 - c)- Vegetable farming
 - d)- Driving training
 - e)- Nature guide training
 - f)- Electric and plumbing training
 - g)- Cook and hospitality training

- h)- Wool spinning and carpet weaving
- 4. During community consultation, NTNC was informed that due to festival months in Nepal; it is highly likely that poaching and IWT activities might increase in the project site. There fore we have installed five automatic motion sensor camera traps in strategic location to deter the potential wildlife poaching and detect early if it happens.
