Output 1 - Situational analysis report on prosecution of IWT in Sri Lanka produced

Output 2 - Wildlife Trafficking and Conservation Course for SLaWEN Officers and network building established

The project team lead drafted a Working Paper that serves as the MOU for SLaWEN institutions going forward. The paper was submitted to the Director of Operations at the Department of Wildlife Conservation, who heads SLaWEN currently, for his approval. The final document has been shared with the relevant institutions for their recommendations, which will be presented at the upcoming program development meeting on November 3rd. Output 3 - Judicial enhanced awareness of IWT in Sri Lanka

3.1 Judicial officers with enhanced awareness of IWT across 25 districts by end of year – The Awareness and Sensitization program for the Judiciary was held successfully for 3 days in Giritale in collaboration with the Sri Lanka Judges Training Institute, with the participation of 25 Magistrates representing the whole country. The training was delivered by the project experts and other academics and experts in the relevant fields on a multitude of topics ranging from the Status and evolution of wildlife conservation and management in Sri Lanka to the Impact of wildlife trafficking on conservation and law enforcement - the challenges and risks faced by law enforcement officers. The program was significantly enriched by the field excursion to the breathtaking Kaudulla National Park and a visit to the Museum of Giritale, at the Department of Wildlife Conservation Training Centre maintained by the Department of Wildlife Conservation.

The assumptions hold true. However, the progress against the indicator 3.2 40% increase in number of IWT cases relating to project focus species presented in court can only be reported towards the end of the program as the judiciary training was only held during September 2023. (Annex 02 – Report on the Judiciary Awareness Program)

Output 4 - Relationship building forum launched with Enforcement, Prosecutor and Judiciary representatives.

To discuss the specifics of this forum and conclude the preliminary planning, a meeting was arranged with the project experts. The agenda for the discussion was drafted. To discuss the project and the goals of the forum, a meeting with prospective judges has been scheduled for November. Additionally, it was decided to invite Attorney General's Department members to the forum. It is too early to say whether the assumptions are true. The forum is scheduled to take place on November 24, 2023. (Annex 03 – Draft agenda for the forum)

Output 5 - A mechanism for excellence awards for officers from SLaWEN initiated.

A meeting with experts was organized to discuss the guidelines (criteria) for indicator 5.1 Guidelines are being developed by a committee for the selection of an enforcement personnel as the awardee by August 2023. The proposed criteria will be forwarded to the Department of Wildlife for approval in the following month. It is too early to say whether the assumptions are correct. (Annex 04 – Meeting minutes with the criteria developed).
