1. Outline progress over the last 6 months (April – September) against the agreed project implementation timetable (if your project started less than 6 months ago, please report on the period since start up to end of September).

We focused on three main tasks during the first half of 2024-2025:

1.vi. Collaborate with local communities and law enforcement agencies to document and act on results of patrolling activities: The Municipal Autonomous Governments (GAM) of Aiquile, Pasorapa, Saipina and Comarapa have hired municipal technicians with a contribution investment of 60% of salaries paid by the GAM's and 40% of salaries paid by the IWT project. The project also hired two municipal managers whose tasks will comprise:

- Leading the management and promoting the visibility of the macaw protected areas in their assigned municipalities, and
- Consolidating community monitoring and camera traps in the protected areas at the local level, documenting and acting on patrolling results, liaising with law enforcement as and when required, and initializing the operation the Protected Area Management Committees.

Also, we are on track for an announcement by the end of October, that the governments of Comarapa and Saipina will have ratified the legal documents to create two new protected areas

2.ii. Offer incentive packages for community patrolling and on individual land parcels in communities close to all important macaw nesting, foraging and sleeping sites; 2.iii Sign conservation agreements with community authorities and volunteer landowners; 2.iv Deliver compensation packages (i.e. bee hives, irrigation systems, fruit tree seedlings etc.): On August 15, 34 families from the Hoyadas community in the municipality of Totora agreed to better conserve Red-fronted Macaw and committed to conserve 1,304 hectares of forested nesting sites and forage areas. Community members signed their conservation agreements in the presence of their local authorities (Mayor, Municipal Council and community leaders), and in exchange for their commitment, received water tanks, barbed wire and corrugated iron, material that will allow them to store and harvest water and protect their water sources from cows.

Similarly, on August 21, in the community of Chajra Mayu, in municipality of Presto in Chuquisaca, 606 hectares of forest was put under conservation agreements within the El Palmar Integrated Management Natural Area. 19 families will benefit from materials provided by the Municipal Government of Presto and the project.

In the community of Quinori, Pasorapa, Mayor Ismael Ríos, hosted an event with community representatives to highlight the importance of their commitment to conservation. Community members have agreed to conserve 96 hectares of nesting sites and 1709 hectares of macaw forage areas. In exchange, 47 families will benefit from a project that will install more than 60 water meters to promote more efficient use of the resource in the community.

3.2.iii Support municipal implementation of Municipal Macaw Conservation Incentive Programs fund as the governments purchase development projects and take on long term project management: In September we held a meeting of 15 municipal technicians and authorities and representatives of the management committees of 2 protected areas to exchange lessons of what they have learned from the project and how they hope to continue conserving the macaw. Invited municipalities were Aiquile, Pojo, Saipina, Comarapa, Pasorapa and Omereque. This event was designed to promote the exchange of experiences, strengthen the knowledge of municipal technicians, management committees and community monitors, and improve conservation strategies for the Red-fronted Macaw. In the event we:

- Trained municipal technicians and authorities and representatives of management committees in the management of municipal protected areas.
- Shared successful practices and lessons learned in the management of municipal protected areas and conservation areas, identifying joint actions and strategies for the conservation of the red-fronted macaw.
- Strengthened the institutionality of municipal governments committed to the conservation of the red-fronted macaw, by preparing (draft) a manual of functions for those responsible for municipal protected areas. This manual will focus on:
 - Creation and Design of Municipal Protected Areas.
 - Governance and Institutionality of the Protected Area.
 - Planning of the Management of the Protected Area.
 - Effective monitoring, control and surveillance of a municipal protected area.

Comarapa is another example of how we are strengthening the Municipal Conservation Funds. Natura, and the IWT project are not contribute cash to the Conservation Fund, rather we have provided technical support that has allowed the Fund to consolidate its own financing namely:
