1. Outline progress over the last 6 months (April – September) against the agreed project implementation timetable (if your project started less than 6 months ago, please report on the period since start up to end of September).

During the past 6 months, the two decreed SMART patrol teams, consisting of 20 community members, 3 BKSDA officials and 5 village officials, continued their monthly patrolling efforts in Karimata Marine Reserve. They covered 42.95% of the total 190,945 ha of the marine reserve and have identified numerous observations across 15 different types of legal and illegal human activities, which have been reported to the BKSDA (the official management and enforcement institution) during a quarterly report and an SMART patrol evaluation session *(output indicators 1.1 - 1.5)* 

In addition to the SMART patrol teams, 10 community members have been trained to lead sea turtle monitoring activities. Since the start of the monitoring activities in February 2024, the team has found 47 turtle nests of which 9 are known to have successfully nested and 38 have

been found poached; 23 by humans and 15 by other perpetrators. However, monitoring has only recently begun and thus still needs time to indicate changes (% increase) in the rate of nesting success. These initial results do indicate the importance of the project and turtle monitoring activities as poaching is prevalent (output indicators 2.1 - 2.3).

As of October 2024, the 4 Conservation Cooperatives (CC) as the local community governance body have a total membership base of 346 individuals (40% women) directly enrolled and an additional 312 (59% women) indirect beneficiaries through household members. We continue to support the management and operations of the different working groups of each CC. During the reporting period, the community finance working groups of the 4 CCs have seen a growth of 22,83% in savings and loans activities and a loan repayment rate of 86% of loans taken out >1 year ago (output indicators 3.1 - 3.5). Also, we have assessed the governance independence level using the 25 applied indicators that led to a result that the 2 CCs in Betok Jaya Village were at developed (berkembang) status and the 2 CCs in Padang Villages were at advanced (maju) status (output indicator 5.4).

The 3 commodities identified as economically valuable (squid, seaweed and mackerel), have also been classified as extractive activities by the BKSDA and thus cannot be further developed as livelihood activities. This means we have to explore other commodities which can be legally developed as new livelihood activities. This is on the agenda for the beginning of 2025, but might extend beyond the project timeline (*output indicators 3.6 - 3.7*). The BKSDA has already approved a fisheries data feedback session, which is planned for the end of October 2024. The outcomes of this will also impact the development of fisheries management plans.

About 557 households are routinely visited each month by the 33 trained Health Ambassadors (HAs), with a report for the Puskesmas on the health issues encountered planned for November 2024. We faced some challenges regarding HAs halting operations until their request for additional compensation was met, but a consensus has been reached about increasing the compensation of HAs to acknowledge their important efforts (*output indicators* 4.1, 4.2 & 4.4).

A total 131 people (87 women) have been enrolled in our literacy program to follow the equivalency education program A, B and C. The enrolled participants are now in the process of verification in Indonesia's Primary Educational System before joining the learning program led by tutors who are currently being recruited by the PKBM (Community Learning Centre) as our official partner for the literacy programme (*output indicator 4.3*).

With regards to publications and communications of our programme impact, we have led the publication of a <u>paper on non-participation in local governance amongst community members</u>. Although the study site for this paper was our terrestrial site in Gunung Nyiut, we do follow a similar core model approach in our coastal sites. The paper found that key factors for non-participation are actually not primarily related to financial incentives, but rather to factors such as time, feeling invited and trust. A summary can be read in our most recent blogpost.

We also have a Participatory Impact Assessment (PIA) paper under review on our terrestrial site, which evaluates the CC model impacts on different program outcomes. A similar PIA is planned to be conducted at the start of 2025 in Karimata Marine Reserve. The final report will include updates on this (*Output indicators 6.1 - 6.4*).

In April to September 2024, the Health Family Initiative Working Group of one CC proactively expressed the need for additional incentives for the Health Ambassadors to continue their valuable contributions. The Karimata team worked closely with YPI management and the CC itself, responding promptly to address this request. As a result, a meeting in May 2024 led to an agreement to provide additional incentives, considering the dedication and hard work of the Health Ambassadors' work. 3.
