The Zoological Society of London is implementing a plan to strengthen measures to combat illegal wildlife trade in the W-Arly-Pendjari landscape in Benin.

The W-Arly-Pendjari complex is the largest transboundary protected area in West Africa, spanning over one million hectares across Benin (577,000 ha), Burkina Faso (250,000 ha) and Niger (220,000 ha). It is a key component of the WAP Biosphere Reserve landscape and is recognised as one of the last remaining wilderness areas of international importance in West Africa. The WAP is the last stronghold of the critically endangered West African lion and northwest African cheetah, and it supports the largest population of elephants in West Africa. However, the region faces significant threats from illegal wildlife trade (IWT), compounded by regional insecurity and limited response capacity.

This report summarises progress made during the first three months of the grant period, from July to September 2024, following funding approval in July 2024. This initial quarter focused on essential administrative tasks to launch the project, including the development of the work plan and Monitoring, Evaluation, and Learning (MEL) plan, as well as planning meetings with implementing partners.

1. Work plan and MEL plan

During July and August 2024 our focus was on preparing the team for project implementation. This included mobilising additional roles within the project team (such as law enforcement trainers) establishing all necessary processes and developing a detailed work plan.

The work plan outlines objectives, tasks, timelines, and resources required to achieve the project's goals, serving as a roadmap to guide the team towards successful completion and enabling progress tracking.

Weekly meetings will be held to monitor adherence to the timeline, promptly address any challenges, and adjust the plan as needed. By following this work plan, the team aims to achieve the project objectives efficiently within the specified time and budget. Regular updates and open communication will be maintained to ensure the project's success.

2. Planning meetings with the implementing partners

In September 2024, a consultation meeting was organised with the key partner, the General Directorate of Water, Forests and Hunting of Benin. The meeting focused on aligning the activity implementation schedule and the project launch with the detailed work plan.

During this period, a scoping meeting was organised with the local partner, the NGO Initiative for the Preservation of Life (IPV), selected to implement community-based income-generating activities supported by the project. This meeting enabled the establishment of a clear framework for effective community involvement in achieving the project's objectives. It also provided an opportunity to review impact indicators for community support and to align the project with the Environmental and Social Management Framework (ESMF) requirements, specifically the Complaints Management Mechanism (MGP) for the WAP. The MGP-WAP is an organised, institutionalised process developed by WAP stakeholders to systematically receive, investigate, and address complaints or concerns from community members in the WAP area. Such complaints may relate to potential misconduct by law enforcement officers or other conflicts involving WAP conservation actors or projects. Concerns and complaints raised by community members of WAP will help the project better understand how its impacts are perceived and experienced locally.

The effective commencement of activities is scheduled for the third quarter (October 2024). Including Basic Law Enforcement Training (BLET), Law Enforcement Advanced Practitioner

(LEAP) training, as well as support initiatives for community projects and awareness campaigns			
in villages surrounding the WAP.

As field activities did not commence in the first quarter, we can't report specific challenges the project has encountered. However, the announcement of the project's approval for funding was very well received by our partners. The project has been designed to address specific needs identified by Benin's government law enforcement agencies, who have shown strong interest and readiness for the initial training sessions.			
The intervention of the IWT project will help establish a new partnership framework with Benin's law enforcement services and agencies including customs, border police, forestry and judiciary through capacity building activities.			
Furthermore, the project aims to enhance local communities' perception of conservation by supporting income-generating activities (IGAs), delivering direct benefits to these populations.
