

Here we report the first two months of the project implementation, having commenced in August. Detailed project implementation planning has taken place with our local delivery partner Biometepe through two working sessions, to work through the project implementation plan with definition of roles and responsibilities to create a detailed shared work plan according to the project indicators. We have also held an initial meeting with representatives of the Nicaragua Ministry of Environment and Natural Resources (MARENA) to present the project and the methodology of Situational Crime Prevention, and agree the steps to follow for the project implementation. We have produced a short video on the project and species in association with MARENA for online dissemination.

We have worked with Biometepe to carry out the annual census (Outcome indicator 0.1, supporting Outcome indicator 0.2) of the Yellow-naped Parrot (YNP, *Amazona auropalliata*) in six communities of Ometepe island (Mérida, La Palma, Balgue, Pull, Las Cuchillas and Peña Inculta) in August-September. Their distribution is uneven across the sites, with varying population sizes and individual trends. The total population trend is positive, with a count of 1502 individuals flying free in 2024, an increase of 8.6% from last season in 2023 (1383 individuals) - following a similar increase (9.2%) from 2022 (1267 individuals).

We have also identified specific potential sites for the installation of camera traps (see map), with a total target of 40 trees in the communities where YNP nesting is monitored (Output indicator 1.1). A Data Management Protocol has been drafted through a series of meetings between specialists in Fauna & Flora's HQ in the UK and the project team in Nicaragua, to cover procedures for all stages of the process – from the installation of the camera traps to their data collection, checking, cleaning and analysis. This considers all the protocols and mechanisms of Fauna & Flora, including on Social Safeguards (Output 1 assumptions).



A questionnaire survey has been developed between the Fauna & Flora specialist in the UK and the Nicaragua project team to measure the baseline perceptions of community members (Output indicator 1.2, supporting Outcome indicator 0.3) prior to implementation of the Situational Crime Prevention strategies. This instrument will be validated by conducting 10 pilot interviews, and then proceed to conduct all the 100+ interviews in the coming months. Fauna & Flora staff have also collaborated to elaborate a grievance mechanism, which sets out everything related to complaints and suggestions that may be made to our established contact point, as part of our approach to Safeguards and Social Safeguards. This mechanism will be made available soon, for example in relation to the installation of signs for the communities on the use of cameras.

The delay in the approval of the project start has resulted in an imbalance in the initial phase of this project, however this is not considered to represent a significant risk for the project execution as we have revised our implementation plan to the reduced project period.

In August the Nicaraguan government brought in new legislation to reform how NGOs can operate, adding to the existing requirements for NGOs to inform and obtain specific government approval to collaborate in proposed project activities. We are now in the process of seeking revised approval for alliances with MARENA.

A delay was experienced by Biometepe in getting government approval to release the funds transferred by Fauna & Flora to their bank for the first year of project operation, resulting in some reduced spend on early project implementation activities.

Lastly, we submitted a change request on our revised members of staff from then original proposal which has been approved (see below).
