This project is being implemented in the Nepal's Sudurpaschhim Province that shares border with China and India. It aims to engage traditional hunting communities and strengthen law enforcement to curb poaching and IWT through innovative alternative livelihood support, minimizing retaliatory killings of wildlife, increasing conservation awareness among local communities and strengthening law enforcement capacity. The IWT and HWC mitigation activities are concentrated in the IWT and HWC hotspots of the province, while the law-enforcement capacity development and conservation awareness activities are being implemented province-wide.

The start date of our project is August 01, 2024. However, it went through Overseas Security and Justice Assistance (OSJA) clearance. We received the clearance notification on September 23, 2024. The project was signed on September 27, 2024. Thus, we were only able to begin project implementation on October, 2024. This report thus presents the one-month progress of the project. During the period the project team was formed and oriented on project objectives and goals, logical framework, safeguard and reporting requirements.

Project sharing meeting with the implementing partner: Informal sharing meeting was conducted with the implementing partner-Community Development Center (CDC). We shared the details roles and responsibilities, safeguards, reporting requirements and resources available with the implementing partner. A formal agreement with the partner will be made soon.

Project sharing workshop with the provincial authorities: A formal project sharing was made with >70 provincial authorities (Minster, Secretary and high-level officials of MOITFE, Divisional Forest Officers, and PA officials of Sudurpaschhim province, and conservation partners of Nepal government). Authorities were informed on project goals, objectives, major activities/milestones and methodologies. We utilized the platform of Annual Progress Review Meeting of MoITFE to make this sharing.

On March 2024, we received a provisional approval of the project. The comment received on Overseas Security and Justice Assessment was as follows:

 As the project has a role in providing security and justice assistance, assurances are required this will be done in line with HMG values on Human Rights. Please note funding is subject to adequate completion of the Overseas Security and Justice Assessment (OSJA).

NTNC sent a response letter to Defra on March 2024 assuring to ensure security and justice during implementation of project as follows:

"Dear Sir/Madam,

This letter serves to provide assurance that National Trust for Nature Conservation (NTNC) will meaningfully engage with the Government of Nepal (GoN), project partners, local communities and stakeholders in the implementation of this project such that human rights values of both His Majesty's Government of United Kingdom and GoN are duly maintained. NTNC abides to the Constitution of Nepal (2015) that provides fundamental rights to all Nepali citizens which is also in spirit with HMG's values of freedom, human rights and the rule of law. NTNC assures that this project's wildlife crime enforcement activities will be undertaken with due considerations to preserving the human rights by avoiding unlawful and unfair legal exercise. In doing so, NTNC will ensure that law enforcement officials are provided with adequate trainings on human rights and any human rights violations that may occur as a result of this assistance will be managed according to the GoN's legal procedures.

We understand that this assistance will be subject to Overseas Security and Justice Assessment and the risks identified will be duly mitigated by NTNC as per the recommendations of the assessment. We would like to bring to your kind attention that NTNC has no past record of human rights violations and it adheres to ethical and human rights standards under the Constitution of Nepal. Thank you.

• To ensure the level of risk remains low, Defra will not fund the spy camera activity and request this activity be removed from the project.

• Ensure strong messaging on International Humanitarian Law (IHL) and Human Rights (HR) expectations are included in scheduled engagements and any training.
