Introduction

- Vast number of applications with few through to Stage 2
- First time including Evidence and Scale projects
- Reaching Stage 2:
 - Strong application with significant potential
 - Clearly addresses pillars but also well written and shows potential
 - Strong likelihood of succeeding in Stage 2
 - Recognition of the level of work involved for Stage 2

The Basics

- Read the Guidelines carefully, make sure you cover all the questions
- Address any issues or questions from the feedback in the letter but also in the text
- Address each question don't neglect:
 - poverty alleviation
 - gender
 - human rights and ethical issues
 - outline the methods
- Decide on project type and pillar following the guidance don't just tick all the pillars

Helping the assessors assess

- Clear Goal (What?), Methods (How?), Outcomes, Impact
- Start with 'Why? not the What or the How
- Applications should be clear and easy to understand don't assume all the reviewers have experience in that topic or geography.
- Don't make your application overly complex or technical.
- Don't assume prior knowledge of reviewers e.g., previous projects
- No BS
 - honesty and integrity score high
 - Acknowledge the work of others
 - Acknowledge lessons from previous work and show you have adapted

Naomi's Tips

- Demonstrate necessary skills and experience. If you don't have it, hire it. If you don't know it say so. Be honest.
- Review ongoing/existing initiatives (activities and location) how does yours evolve the response? Who else has tried this work before? How are you building on that?
- Stretch targets are good but you also need to be realistic especially with the time it takes

Naomi's Gripes

- Acknowledge constraints don't say you can do something that is unlikely or achieve something big in a tight timeframe
- Be evolutionary build positively upon what has gone before (N.B. evolution is slow), don't just repeat it, especially if it didn't work the first time.
- Ignore the efforts of others, current or previous.
- Ignoring local partners work WITH them.
- Offer value for money.
- Using sophisticated techniques inappropriately/dangerously.
- Unethical/unjust goals e.g., high/unfair arrests and prosecutions.
